# Campaign Support Committee Recommended Policies for Public Phase

#### As of May 1, 2020:

- 1. Pledge period becomes 24 months.
- 2. Gift must be \$2,500 or more to be pledged out over time, and pledging becomes a benefit of joining the Founders' Society.
- 3. Three payment options are available:
  - a) Quarterly
  - b) Semi-Annually
  - c) Annually
- 4. Pledge cards no longer required for gifts outright.
  - a) Staff will continue to verify acknowledgement on gifts of \$2,500 and above.
- 5. Gifts of less than \$2,500 will be acknowledged by email.
- 6. Paver campaign is entirely transactional.


