Dear Justin:

I am pleased to confirm that Deloitte Consulting LLP ("Deloitte Consulting") will provide consulting services as set forth in this Engagement Letter (the "Services") to assist Cain Center for the Arts (the "Client") in connection with Client's managerial reporting activities (the "Project").

OUR UNDERSTANDING OF YOUR OBJECTIVES

The Cain Center is nearing completion of the construction of its new facility and has been expanding in size and services offered since its creation in 2017. It is looking for Deloitte's assistance in developing managerial reporting and controls to assist The Cain Center executive director in running the growing organization. Specific challenges identified include how to manage and consolidate four departmental budgets, managerial reports that accurately and consistently reflect spend vs. budget, and track progress against organizational goals and objectives.

PROJECT SCOPE AND APPROACH

Deloitte Consulting will assist the Client with the following activities associated with the Project:


- Conduct a current state assessment of the organization's budgeting, reporting and controls
 process and technology to provide a baseline of current capabilities;

- Support the client to assess whether it is preferable to purchase a commercial off-the-shelf technology solution or use one of the Cain Center's existing applications (create a set of department-level workbooks/templates in Microsoft Excel);
- If appropriate, document the new process, build the Excel workbooks/templates, and conduct knowledge transfer to teach the Executive Director and other key stakeholders how to use them.

- If the Cain Center elects to move forward with the build decision, the Cain Center is solely responsible for maintaining the Excel workbooks/templates and confirming that the deliverables perform the way the Cain Center intends.
- If the Cain Center elects to move forward with the buy decision, the Deloitte team will research and present a maximum of five (5) 3rd party vendor budgeting systems for the Cain Center to consider.
- Deloitte Consulting has the right to use the Client name and logo in its deliverables for this project, as well as indicated in the GBTs. Such use of the logo will be used in promotional materials to recruit talent within Deloitte Consulting and to initiate new projects with nonprofit clients.
- Client will not provide Deloitte Consulting any Protected Health Information or Personally Identifiable Information in connection with the Project. Client will immediately notify Deloitte Consulting if any such access is provided.
- Should any key stakeholders become unavailable for an extended period, Client will endeavor to identify other available personnel to avoid timeline adjustments.

This engagement may be terminated by either party at any time, with cause, by giving written notice to the other party not less than five (5) business days before the effective date of termination; provided that, in the event of a termination for cause, the breaching party shall have the right to cure the breach within the notice period. Either party may terminate this engagement or performance of any part of the Services at any time for convenience upon written notice to the other party.
- 3. Upon completion of the Services and subject to the terms and conditions herein, Deloitte Consulting hereby grants Client a royalty-free, fully paid-up, non-exclusive license to use, for Client's internal business purposes, the works of authorship, materials, information and other intellectual property delivered to Client as a result of the Services provided hereunder (the "Deliverables"). The disclosing party hereby consents to the receiving party disclosing such information (i) to contractors providing administrative, infrastructure and other support services to the receiving party and subcontractors providing services in connection with this engagement, in each case, whether located within or outside of the United States, provided that such contractors and subcontractors have agreed to be bound by confidentiality obligations similar to those in this Section 8(a); (ii) as may be required by law or regulation, or to respond to governmental inquiries, or in accordance with applicable professional standards or rules, or in connection with litigation pertaining hereto, or (iii) to the extent such information (A) shall have otherwise become publicly available (including, without limitation, any information filed with any governmental agency and available to the public) other than as the result of a disclosure in breach hereof, (B) becomes

- available to the receiving party on a nonconfidential basis from a source other than the disclosing party which the receiving party believes is not prohibited from disclosing such information by obligation to the disclosing party, (C) is known by the receiving party prior to its receipt from the disclosing party without any obligation of confidentiality with respect thereto, or (D) is developed by the receiving party independently of any disclosures made by the disclosing party to the receiving party of such information. In satisfying its obligations under this Paragraph 8(a), each party shall maintain the other's trade secrets and proprietary or confidential information in confidence using at least the same degree of care as it employs in maintaining in confidence its own trade secrets and proprietary or confidential information, but in no event less than a reasonable degree of care. Nothing in this Paragraph 8(a) shall alter Client's obligations under Paragraph 8(b).
- b) Client agrees that neither the Services nor any Deliverables are intended for the express or implied benefit of any person or entity other than Client. Client further agrees that the Services and Deliverables shall not be disclosed, in whole or in part, to any person or entity other than Client.
- 9. All provisions which are intended by their nature to survive performance of the Services shall survive such performance, or the expiration or termination of this engagement. In the event of any conflict or ambiguity between these terms and the Engagement Letter, these terms shall control. Each of the provisions of these terms shall apply to the fullest extent of the law, whether in contract, statute, tort (such as negligence), or otherwise, notwithstanding the failure of the essential purpose of any remedy.
- 10. Client may not assign, transfer or delegate any of its rights or obligations (including, without limitation, interests or Claims) relating to this engagement or the Services without the prior written consent of Deloitte Consulting. Client hereby consents to Deloitte Consulting subcontracting any of Deloitte Consulting's rights and obligations hereunder to any affiliate, whether located within or outside the United States.
- 11. THE PARTIES HEREBY IRREVOCABLY WAIVE, TO THE FULLEST EXTENT PERMITTED BY LAW, ALL RIGHTS TO TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM RELATING TO THIS ENGAGEMENT.
- 12. These terms, and the Engagement Letter, including exhibits, constitute the entire agreement between the parties with respect to this engagement, supersede all other oral and written representations, understandings or agreements relating to this engagement, and may not be amended except by written agreement signed by the parties. All notices hereunder shall be (i) in writing, (ii) delivered to the representatives of the parties at the addresses set forth in the Engagement Letter, unless changed by either party by notice to the other party, and (iii) effective upon receipt.

- These terms, the Engagement Letter, and all matters relating to this engagement, shall be governed by, and construed in accordance with, the laws of the State of New York (without giving effect to the choice of law principles thereof). Any action based on or arising out of this engagement or the Services shall be brought and maintained exclusively in any court of the State of New York or any federal court of the United States, in each case located in New York County, the State of New York. Each of the parties hereby expressly and irrevocably submits to the jurisdiction of such courts for the purposes of any such action and expressly and irrevocably waives, to the fullest extent permitted by law, any objection which it may have or hereafter may have to the laying of venue of any such action brought in any such court and any claim that any such action has been brought in an inconvenient forum. If any provision of these terms or the Engagement Letter is found by a court of competent jurisdiction to be unenforceable, such provision shall not affect the other provisions, but such unenforceable provision shall be deemed modified to the extent necessary to render it enforceable, preserving to the fullest extent permissible the intent of the parties set forth herein.
- 14. As an inducement for Deloitte Consulting to perform the Services without payment of professional fees, Deloitte Consulting or its affiliates shall be permitted to photograph or videotape Client's personnel and property for use in any publicity, marketing, advertising or promotional materials or activities or any other uses that Deloitte Consulting may, in its sole discretion, deem proper.
